# E. Superintendent Report

#### 2025-2026 Calendar-

Mrs. Filyaw shared the proposed calendar at the meeting. The board requested that Mrs. Filyaw survey the staff to determine if there is any way to be finished prior to Memorial Day, should all snow days be used. In addition, the board discussed the possibility of year round school. Mrs. Filyaw will also ask a question regarding year round school on the survey. The calendar will be approved next month.

## FCB Repurchase Agreement-

Recently, the district entered into a repurchase agreement with FCB that allows the bank to invest and dollars over \$100,000 from the district's checking account. Mrs. Filyaw shared that the district still has access to that money should we need to write a check or run payroli that is over \$100,000.

### F. Principals' Report:

The principals provided updates on their buildings highlighting the many great activities that are occurring. Mrs. Bonsall discussed the upcoming annual reviews.

#### II. Public Comments:

Robert Brown attended the meeting and stated that he and his family have all been graduates of Wesclin School District. He is also a member of the United Methodist Church, and stated that there are options available in the community for religion to be taught to students. There are youth groups, bible study, etc. and he believes that should remain outside of school.

Angie Evans stated that due to the snow days that have been used this year, there are now exams being held after Memorial Day. She believes that e-learning should be reinvestigated.

Melanie Frederich stated that she is surprised that the district does not incorporate e-learning on snow days. She believes that after 3 snow days, e-learning should be an option. Melanie finished by stating she agreed with Mr. Brown on the religion course addition at the High School, and that a religion elective should not be in a public school.

Nick Hollenkamp addressed the board regarding entering into a cooperative agreement with Lebanon School District to offer football. He also stated that having to compete in 3A does not scare him. He was going to contact Lebanon to determine the interest.

### IV. Items Requiring Board Action

#### A. Spectrum Enterprise Contract Renewal

Every three years the district's contract with our internet provider gets renegotiated. Part of the bill is reimbursed through the E-rate grant from the federal government. Spectrum was the only provider that offered a quote.

Currently, all lines come into the Middle School and then get distributed to the other three buildings. Therefore, if the line coming into the Middle School goes down, all buildings are down.

The new proposal establishes separate lines for both elementary schools. Therefore, if the Middle School goes down, both elementary schools would not be impacted. The renegotiated price is actually \$15.90 less expensive per month after the E-rate discounts are applied.

### B. Health Insurance Assessment

Egyptian Trust, the district's health insurance carrier, is a self-funded insurance carrier. Mrs. Filyaw stated that unfortunately, as a cooperative school, the medical costs are exceeding the premiums that the trust is collecting. The trust anticipated a 9% increase for overall health insurance costs this year, and currently it is a 16% overall increase. Because of the loss ratio at the time of renewal, Mrs. Filyaw shared that the renewal rate was 7.2%.

Mrs. Filyaw stated that the district has 16 employees that access our health insurance and our loss ratio is at 131.2% (which is up from 99.43% loss ratio a year ago.) Therefore, as a district we are being charged a \$31,876.00 assessment (which is \$1,992 per employee.) Although the employees pay for their health insurance, Mrs. Filyaw is not recommending that this assessment be charged to

the employees as it is not being assessed on each employee directly. It is being assessed on the overall loss ratio but calculated per employee. It is not based on the plan that they access nor each individual employee's overall loss ratio.

Mrs. Filyaw stated that she does anticipate a significant percentage increase at renewal which is at the start of the school year.
